All professional players and their support personnel should apply for **Temporary Activity Visa** (subclass 408). Persons found working in Australia on the wrong Visa type (tourist - Visitor Visa, ETA, eVisitor) may have their Visa cancelled.

You cannot enter Australia after your indicated departure date; e.g. I apply for 25 December 2018 to 31 January, 2019 – I will not be allowed to enter Australia after the 31st January. <u>Do not include family members</u> on your Work Visa application as it can create significant delays in the processing time. <u>408 Visa can only be applied for outside of Australia</u>

You cannot participate in the 2019 Australian Open and / or Series until you have been granted an appropriate 408 Visa with working rights

Already hold a valid Visa?

If you currently hold a valid visa to enter Australia, please check with your nearest Australian embassy for your Visa entitlements. Applying for a new Visa will cancel your old one so please check.

Family / friends attending AO 2019?

Family members or friends attending the event <u>as a guest, in a non-working capacity</u> may apply for a tourist visa. These include:

- ✓ Visitor Visa (subclass 600)
- ✓ ETA (subclass 601)
- ✓ eVisitor (subclass 651)

*All visitors to Australia must have a valid visa to travel to and enter Australia (other than New Zealand passport holders who will normally be granted a Special Category visa on arrival, provided they meet the health and character requirements; and permanent residents of Norfolk Island who may be granted a Permanent Resident of Norfolk Island visa on arrival).

Will remuneration be received for undertaking the activity in Australia? Answer **"No",** as Prize Money is not considered remuneration.

Do I need to give my health insurance details?

You must provide your health insurance details to continue with the application process. Information requested are: Name of health insurance provided and Period covered.

It is not mandatory to provide proof of health insurance for stays of up to 3 months, although you may be randomly selected to provide this in some cases.

What should I specify as my "type of health insurance cover"?

Immigration needs to know that you have sufficient health insurance. Suggested examples can be **"comprehensive"** or **"full coverage"**. See above.

What documents must I attach to my application for a 408 visa?

- Copy of your passport information page (showing your photo and details)
- Letter of invitation (please email DONeill@tennis.com.au to request one)

After you attach the above two documents, there will be a pop-up window asking you why you have not attached all of the documents they requested (Financial & Health).

Explain why evidence cannot be provided at this time?

Answer this question by advising "Please see invitation letter attached"
